General Lottery Rules

The Gallatin Valley Farmers' Market is held June through September on Saturdays from 9:00 a.m. – 12:00 p.m. at the Haynes Pavilion at the Gallatin County Fairgrounds in Bozeman, Montana.

Between 7:30 and 7:45 am, lottery vendors should enter the fairgrounds through Grand Gate Entrance and make their way to the "Lottery Sign-Up," table located to the North of Exhibition Building 3. (LOTTERY PLACEMENTS ARE NOT FIRST-COME, FIRST-SERVE. Showing up before 7:30 am will not help their chances of getting placed.) Lottery vendors will either fill out a new application form and/or check-in with market staff to pull their form if returning during same market season. Lottery vendors will then be given a ticket. Tickets will be drawn to place lottery vendors in available spaces at 8:00 am. Please be present at "Lottery Sign-Up," table to wait for your number to be called. Lottery vendors will pay for space when their ticket is drawn. Please be prepared with cash or check. After vendor's ticket has been selected & vendor has paid, market staff will show them to their space. Lottery vendors are not permitted to drive their vehicle inside the pavilion during load-in. There are no guaranteed spaces.

Prices: These are weekly fees which are paid before setting up.

- Regular 4' x 8' space inside pavilion: \$20
- Young Entrepreneur (18 or younger) 8' x 8' space inside pavilion: \$20
- Regular 5' x 10' space outside on lawn: \$20
- Young Entrepreneur (18 or younger) 10' x 10' space inside pavilion: \$20
- Regular 8' x 8' inside pavilion: \$25
- Regular 10' x 10' space outside on lawn: \$25

Rules and Regulations

- Items sold at the market MUST BE handmade or homegrown by you. the vendor.
 Value-added food products with any "potentially hazardous" ingredients requires a food license from the Gallatin County Health Department. Contact our manager and they can assist you further.
- 2. Sellers are required to be ready to sell when the market bell rings at 9:00 a.m. **and not before**, and sell until 12:00 pm.
 - p.m. when the bell rings to end the market. You may only sell to vendors before 9 a.m.
- 3. Sellers must provide their own tables, chairs, change, bags and advertising signs.
- 4. Sellers **MUST CLEAN THEIR OWN AREA** at the conclusion of each market. <u>There will</u> <u>be a charge of \$25 if we have to clean up after you</u>. Be considerate and pick up trash whenever you see it.
- 5. NO smoking, or weapons are allowed in the market area.
- 6. If you have a dog at your booth, (outside spaces only) **THEY MUST BE WELL TRAINED AND FRIENDLY**. If our manager notices problems with your dog, they will be asked to be taken off the property.
